<p>Right of access</p>	<p>Subject to certain conditions, you are entitled to have access to your personal data (this is more commonly known as submitting a “data subject access request”).</p>
<p>Rights in relation to inaccurate personal or incomplete data</p>	<p>You may challenge the accuracy or completeness of your personal data and have it corrected or completed, as applicable.</p>
<p>Rights to object to or restrict our data processing</p>	<p>Subject to certain conditions, you have the right to object to or ask us to restrict the processing of your personal data.</p> <p>This right applies where our processing of your personal data is necessary for our legitimate interests. You can also</p>

	object to our processing of your personal data for direct marketing purposes.
Right to erasure	<p>Subject to certain conditions, you are entitled to have your personal data erased (also known as the “right to be forgotten”), e.g. where your personal data is no longer needed for the purposes it was collected for, or where the relevant processing is unlawful.</p> <p>We may not be able to erase your personal data, if for example, we need it to (i) comply with a legal obligation, or (ii) exercise or defend legal claims.</p>
